Application:

- Can be applied anytime during the initial wetting of the floor for concrete grinding. Can be used for both walk behind processes and ride-on trowel process.
- 2. Apply based on coverage rates above, and as needed during concrete grinding, do not apply over 1,000 sf per gallon per application. Apply directly with water to the floor during the pre-wetting as well as during the grinding stages.

Storage & Shelf Life:

Should be kept in the original container, with the lid fastened tightly. Store in a cool, dry place raised off the floor. Keep in a temperature range of 40–100°F or 4–38°C and DO NOT allow FREEZE. Seal container again after each use. Keep out of reach of children. Do not mix with other chemicals.

Cleanup:
